Mayor LaRosiliere called the meeting to order at 5:46 p.m., Monday, January 11, 2016, in Training Room A of the Municipal Center, 1520 K Avenue. A quorum was present. Mayor LaRosiliere then stated that the Council would retire into Executive Session in compliance with Chapter 551, Government Code, Vernon's Texas Codes, Annotated in order to consult with an attorney and receive Legal Advice, Section 551.071; to receive information regarding Economic Development, Section 551.087; and discuss Real Estate, Section 552.072; for which a certified agenda will be kept in the office of the City Secretary for a period of two years as required.

Mayor LaRosiliere reconvened the meeting back into the Preliminary Open Meeting at 6:35 p.m. in the Senator Florence Shapiro Council Chambers.

Consideration and action resulting from Executive Session discussion

No items were discussed.

Open Carry Briefing

Assistant City Manager Israelson discussed the change in the firearm laws and introduced Police Department Senior Legal Advisor Howard to provide the details. Mr. Howard spoke to the legislation, areas where carrying firearms openly or concealed are allowed or prohibited, notice requirements, and the changes to the statute language. Mr. Israelson provided options to Council regarding firearms during open meetings of the City Council and Boards and Commissions. He stated they could choose no firearms, concealed firearms, or open carry of firearms; and the open meetings in which they were prohibited. The Council expressed concurrence to prohibit all firearms during all Council and Board and Commission open meetings.

Council Member Grady requested Consent Agenda Items “H” & “J” be pulled for individual consideration and City Manager Glasscock requested Consent Agenda Item “B” be pulled for individual consideration.
