Whereas, said Principal desires to engage in the business of collecting and transporting construction debris in the City of Plano, Texas.

Now, therefore, the condition of this obligation is such that, if said Principal shall well and faithfully observe and obey all laws, rules, ordinances, and regulations whatsoever prescribed by the City of Plano, Texas, with respect to the provisions and regulations of the City of Plano Ordinance, then this obligation shall be null and void, otherwise to remain in full force and effect.

It is understood and agreed that the Surety may cancel this bond at any time on thirty (30) days notice in writing to the City of Plano, Plano, Texas, but is hereby expressly provided that such cancellation shall not affect any accrued liability on this bond.
