2013 Monthly Rx Rate



The new monthly Rx rate for 2013 is \$154.63. This is a reduction in premium. The current 2012 monthly premium is \$193.29

AARP Plans “F” and “K”

Note: 2013 deductible amounts have not yet been released therefore the attached plan outlines show 2012 deductibles.

Keep in mind that rate increases for these plans do not take place until mid-year .

United Rx for Groups

There are approximately 30 other plans in which you can enroll. Please refer to the Medicare website at www.medicare.gov.

If you are currently enrolled in the Rx plan but do not want this coverage for 2013, Medicare REQUIRES you to complete an “Opt Out” form. Service Credits & Premiums

- ◆ Service credits apply ONLY to the plans offered by the City of Plano.
- ◆ Service credits apply to the United Rx for Groups Prescription Drug Plan first. Any remaining service credits apply to the AARP plan.
- ◆ United Healthcare Group Medicare Advantage (formerly Secure Horizons) plan covers both medical and prescription drugs therefore the full service credit amount applies to this plan.
- ◆ Because there is a premium change on the Rx Plan, your AARP premium will be affected.
- ◆ AARP will mail out new premium books to those who have a revised AARP monthly premium.
- ◆ If you “opt out” of the Rx Plan, service credits will apply directly to the AARP Plan.
