You can do something about housing discrimination.

Fair Housing is a national policy of the United States. **It's your right and it's the law.**

Discrimination, based on race, color, religion, gender, disability, familial status or national origin, in connection with the sale or rental of most housing and any vacant land offered for residential construction or use, is illegal under Title VIII of the Civil Rights Act of 1968.

HPRP TO THE RESCUE!

The City of Plano Homelessness Prevention and Rapid Re-Housing Program (HPRP) is designed to keep Plano residents from becoming homeless. The program provides rent (not mortgage), utility, and legal assistance to income qualified households that have been served an eviction notice and/or utility cut off notice.

DOES YOUR HOUSE NEED COSTLY REPAIRS? UTILITY BILLS TOO HIGH?

The City of Plano Housing Rehabilitation Program offers housing repair assistance such as those needed to make the home safe and secure, improve energy efficiency, remove hazards such as lead-based paint, and make the home more accessible to persons with disabilities.

Emergency? Eligible households may qualify to receive emergency repairs such as plumbing, electrical and mechanical systems (heating and air conditioning) on their property at **NO COST** to the homeowner.

Am I eligible? Households must meet program standards including the income requirements below:
