ON MAY 13, 2008 AT 12:00 P.M. ONE OR MORE MEMBERS OF THE PLANO PLANNING & ZONING COMMISSION WILL TAKE A TOUR OF SELECTED MIXED USE SITES AND SUBSEQUENTLY HOLD A WORK SESSION TO PRELIMINARILY DISCUSS DEVELOPMENT OF A MIXED-USE POLICY STATEMENT.

THE TOUR WILL START AT THE CITY OF PLANO MUNICIPAL CENTER (CONVENE IN PLANNING CONFERENCE ROOM 2E) WITH STOPS AT WATTERS CROSSING TOWN CENTER, FIREWHEEL TOWN CENTER, BLOCK 24, CAPELLA COURT AND COIT AND CAMPBELL RD. AT EACH STOP, COMMISSION MEMBERS WILL BE BRIEFED ON THE AREA DEVELOPMENT AND HAVE AN OPPORTUNITY TO DISCUSS WITH STAFF, OBSERVATIONS ABOUT EACH DEVELOPMENT.

THE 5:15 PM WORK SESSION WILL INCLUDE SLIDES FROM THESE AND OTHER MIXED USE PROJECTS; DISCUSSION OF SITES VIEWED ON THE FIELD TRIP; THE URBAN CENTERS STUDY (ADOPTED BY THE CITY COUNCIL IN 2006); AND OTHER RELATED DOCUMENTS THAT WILL BE USED TO HELP FORMULATE POLICY RECOMMENDATIONS FOR THE CONSIDERATION OF FUTURE PROPOSALS FOR COMBINING RETAIL, OFFICE, RESIDENTIAL, AND/OR OTHER USES INTO THE SAME PROJECT.
